





# Mukhyamantri Sahari Bikash Yojana (MSBY)



# Converging the existing Schemes




# Sectors under MSBY : 1. Urban Infrastructure



\* A maximum limit of 30% may be allotted for roads and drains under this sector

# Sectors under MSBY : 1. Urban Infrastructure (Cont.)



## Sectors under MSBY : 2. Urban Wage Employment

### 1. Construction of Basic amenities

Minipark, open air gym, child play station, aspirational toilets, playground, walking tracks, wall painting, open space development, garbage vulnerable points (GVP) to a aesthetic public space, infrastructures in slums

### 2. Facilities for the outdoor games

Provision of long jump, high jump pit, rope climbing, hanging bar

### 3. Street Benches

Prime locations as seating places

### 4. Conversion of area under Bridges/ Flyovers

Into Community Sports, Recreational and Cultural Facilities ( At the feasible locations)

### 5. Redeveloping existing facilities

Develop parks and public/ open spaces with LED Boards wherever applicable charging points, small cafes and more

## Sectors under MSBY : 2. Urban Wage Employment

### 6. Afforestation Projects

Green Lungs like Miyawaki forests, Mini Forests, Green Corridors, Avenue Plantation, Afforesting schools, universities and institutional campuses ( Cities above 1 lakh population)

### 7. Maintenance of monuments

Local monuments and heritage buildings

### 8. Basic facilities for devotees

Bhogamandap, Bhagabat Tungi and other cultural centres

### 9. Rainwater harvesting structures

Surface and Roof Top RWHS

### 10. Unskilled labour component

Minimum 25% of the project cost to be ensured

## Sectors under MSBY : 3. Water Body Development

1

Development of river waterfront in cities of Mayurbhanj, Keonjhar, Sambalpur, Cuttack, Khurda, Balasore, Raygada, Koraput, Ganjam,etc

2

Renovation and development of water bodies, bathing ghat and other beautification works

3

Gap funding towards water body rejuvenation taken up under Amrut & other schemes

## Sectors under MSBY : 4. Animal Welfare

1

Development of Kanjia Huda/ Goshalas (integrated cattle hostel) across all ULBs as per requirement to address issues of stray animal management, cattle theft & accidents. **(Facility in 1 acre land for 50 animals)**

Pet care centres, animal birth control and any other animal welfare related activities. **(Facility in 1 acre land for 50 animals)**

# Annual Action Plan

## Planning

All the Stakeholders of Urban area must play their part to achieve the goal set by the Government for creating basic infrastructures and civic amenities in all 2055 Wards across 115 ULBs of the State. Four key principles i.e., accountability, transparency, participation and inclusion are of paramount importance during entire period of implementation of the scheme.

- i. Urban Local Bodies (ULBs) **will prepare detailed annual action plans** in consultation with stakeholders, including elected representatives and technical experts. The availability of the land for proposed projects to be ensured before preparation of AAP.
- ii. Annual Action plans must **prioritize projects based on local needs**, with a focus on infrastructure development, employment generation, and sustainability.
- iii. After finalizing the annual action plan at the ULB level, the **plans are to be shared with the State Level Committee**.
- iv. State level committee will examine whether the Annual Action Plans submitted by ULBs **prepared in consonance with scheme guidelines** and release funds accordingly.
